Implant Related Pathology & Effective Implant Maintenance



Dr. Peter Fritz

Dr. Peter Fritz is a certified specialist in Periodontics and is in full-time private practice in Fonthill, Ontario. The focus of his periodontal practice is dental implant therapy, microsurgical bone and soft tissue reconstruction, and oral medicine.

Dr. Fritz practiced General Dentistry for 5 years before earning a Fellowship in Periodontics from the Royal College of Dentists of Canada. Dr. Fritz considers the most important part of his clinical training to be the completion of a Ph.D. in the molecular biology of bone formation from the University of Toronto. This provides Dr. Fritz with the ability to approach clinical problems from a rigorous scientific perspective.

Dr. Fritz is an Adjunct Professor in the Centre for Bone and Muscle Health, Faculty of Applied Health Sciences at Brock University, Staff Periodontist for the Niagara Health System, President of the Welland District Dental Society, Past-President of the Ontario Society of Periodontists and a Fellow of the International Team for Implantology (ITI). Dr. Fritz has lectured extensively across North America and Europe and has published many articles and book chapters on the topic of implants and bone health.

Course Outline:

This update is essential for every hygienists maintaining dental implants. Although highly successful, a small percentage of patients with dental implants can develop implant associated pathology such as mucositis or peri-implantitis. This lecture will review the etiology, prevention and current treatment protocols of these challenging conditions.

As more and more patients are being treated with dental implants, there is also some uncertainty regarding the appropriate maintenance protocols. This can lead to peri-implant diseases.

This lecture will review in detail an algorithm that is used on a daily basis in a periodontal office that can be used in any hygiene practice as an effective maintenance strategy as well as one to identify patients with potential implant problems.

Principles of Treatment Planning in Dentistry:

A Multi-Disciplinary Approach.



Dr. M.K. (Bobby) Baig

DR. M. K.(Bobby) Baig received his dental degree from HKES Dental College, India.He completed his graduate program in Prosthodontics at Eastman Institute for Oral Health University of Rochester in 2011. In addition he lectures at University of Rochester and University of Toronto besides practising in private clinic.

Course Outline:

Interdisciplinary treatment planning in dentistry should be given priority as early as possible because of the prime importance of diagnosis. Any treatment rendered is multidisciplinary in nature. In this fashion the clinician becomes acutely aware of fine correlations between tooth anatomy, size, position, gingival levels, occlusal status, implant placement, periodontal conditions and over all facial appearance.

Content:

- The discipline of establishing a sound rationale for each and every step one plans to take in treatment plan with critical analysis of diagnostics to establish an ideal treatment planning using case based scenarios.
- The understanding that every case should be approached as if the clinician has never treatment planned or treated a case.
- To review the guidelines of treatment planning to differentiate normal anatomical architecture as compared to deviation from normal.
- To make a judgment upon clinician's experience when to involve other specialists to provide the best possible tx for our patients.
- Advancements and usage of newer technologies for diagnosis and treatment planning.

Dr. Judi Heggie obtained her DDS from U of T in 1987. After graduation she worked as an associate dentist, as a partner in a group practise and in

public health. Dr.Heggie joined the College part time in 1996. She has been with PLP since 1997 in a full time capacity and now is the Colleges' senior dental consultant. She reviews claims against dentists and provides opinions on the dental treatment and damages.

Course Outline:

The Professional Liability Program provides malpractise insurance and risk management advise to Ontario Dentists. It is in the best interest of the dentist to understand the objectives and highlights of PLP policy. In addition all dentists should be aware of elements of dental negligence and be able to determine which situations in their own practise settings may lead to legal actions.

The PLP staff will also present cases that attract the most complaints.

Dr. Neil Gajjar lectures on managing medical emergencies in the dental office, has been a lecturer of oral pathology and clinical instructor at the Canadian Academy of Dental Hygiene, and has served as a clinical instructor in the Oral Diagnosis and Emergency clinics at the University of Toronto, Faculty of Dentistry. Dr. Gajjar is a Master of the Academy of General Dentistry, a Fellow of the Academy of Dentistry International, a Fellow of the Pierre Fauchard Academy, a Regent of the International College of Dentists and has served on both Disciplines and PLP Committees and as Councillor for the Royal College of Dental Surgeons of Ontario. He currently serves as a Clinical Examiner for the NDEB.

Course Outline:

Dr. Gajjar will review the steps to follow when you encounter a medical emergency in your office. A recertification of CPR for Health care providers will be offered as well as the use of an AED for targeted responders. Yearly CPR renewal is required for all office staff and this course presents an excellent opportunity for members of the dental office to stay current with the new changes in CPR protocol.

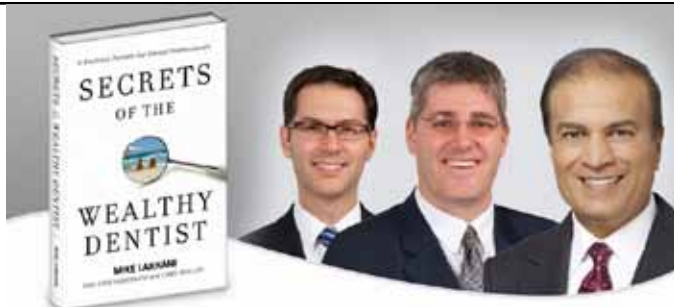

Clinical Endodontics for the General Practitioner



Dr. Viraj Vora

Dr. Viraj Vora graduated with a dental degree (DDS) from the University of Western Ontario in 2005. He practiced general dentistry for three years and then entered the University of Michigan in 2008 where he earned a Masters of Science (MS) and a certificate of specialty in Endodontics. Dr. Vora is a Fellow of the Royal College of Dentists of Canada. Returning to Canada, Dr. Vora practiced Endodontics in London, Ontario for two years before moving to Vaughan in March 2013 to set up his own private practice. Dr. Vora is a lecturer, examiner and clinical instructor at the University of Western Ontario undergraduate Endodontics program. He is also part of the scientific advisory committee for the Journal of Endodontics. Dr. Vora's specific interest in endodontics includes root canal anatomy, outcomes research and materials science.

Course Outline:

- Diagnosis of endodontic disease: Objective is to provide information for predictable analysis of endodontic pathology. Other aspects will include case assessment and patient management.
- Access fundamentals and design: Key principles into creating straight-line access for safe and efficient cleaning and shaping. Various tools will be described.
- Cleaning and shaping of the root canal system: Main irrigating solutions and ways to shape canal systems with overview on a few Ni-Ti instruments.
- Obturation of the root canal system: Comparing various materials and methods used today. Which method of obturation to choose for your practice?
- Epidemiology and outcomes: What do success and failure rates really mean? How does this compare to implants? What is in the future for endodontics?
