He continues to maintain strong affiliation to the University of Toronto as an Associate in Dentistry, where he contributes to the clinical and didactic training of undergraduate and graduate dental.

Topic: Presenting Let's Get Gingival: The Diagnosis and Management of Gummy Smiles

Synopsis

Excessive gingival display when smiling, commonly referred to as a "gummy smile", may be a concern to both patients and clinicians. While not necessarily pathological, it can cause significant aesthetic concerns, and patients often present seeking a solution. As such, having a basic understanding of the different causes and treatment options is essential for dentists. This presentation will review the various etiologies of the gummy smile and discuss both surgical and non-surgical clinical protocols from a periodontal perspective, in order to provide an aesthetic solution for these patients.

Pain Management and analgesic use in the Dental Office: An Overview

Speaker: Dr. Aviv Ouanounou



Dr. Aviv Ouanounou, BSc, MSc, DDS, FICD, FICO

Dr. Aviv Ouanounou is an assistant professor of pharmacology and Preventive Dentistry at the faculty of dentistry, University of Toronto. He received both his DDS and MSc at the University of Toronto. He teaches pharmacology and Preventive Dentistry to undergraduate and graduate students and is also a clinical instructor and Treatment Plan Coordinator. Dr. Ouanounou won numerous teaching awards including winning "Best Teacher of the Year Award" three times: in 2013, 2015 and just recently in 2019. Also, Dr. Ouanounou is the

recipient of the 2014-2015 prestigious Dr. Bruce Hord Master Teacher Award for excellence in teaching at the Faculty of Dentistry at the University of Toronto. Dr. Ouanounou is a Fellow of the International College of Dentists. He is a member of the American Academy of Pain Management and the American College of Clinical Pharmacology. He has published and authored numerous articles in peer-reviewed journals. He also maintains a general private practice in Toronto.

Topic: Pain Management and Analgesics Use in the Dental Office: An Overview

Synopsis

One of the most common sequela associated with dentistry and dental treatment is acute post-operative pain. Almost every procedure associated with dental treatment has the potential to cause some degree of post-operative pain requiring multi-faceted management. Today's clinician has a large armamentarium of pharmacological agents to draw from to control acute post-operative pain. Depending on the anticipated severity of postoperative pain, these agents may include acetaminophen, non-steroidal anti-inflammatories (NSAIDs) and opioids. Attendees in this lecture will be introduced to evidence-based information related to the basic mechanisms of pain, the pharmacology of analgesics and the rationale for the selection of an analgesic for the treatment of acute odontogenic pain. Also, other newer analgesics (particularly used for chronic facial and TMJ pain) will be discussed. The common adverse drug reactions and drug interactions associated with these agents will also be discussed.

Learning Objectives

1. Discuss the physiology of pain
2. Review and discuss the pharmacology of the most common analgesics used in dentistry to treat acute and chronic pain
3. Recognize potential drug interactions and adverse drug events associated with the use of analgesics commonly prescribed by dental practitioners and understand the importance of organ function/ disease status in altering the absorption, distribution, metabolism and therapeutic action of dentally used analgesics.

Topic: Implant Prosthetic Components Mishaps: Loosening vs Fractures

Synopsis

Dental implants have been a life-enhancing modality for partially and completely edentulous patients. Implants can successfully support prosthetic restorations.

However, this modality is not without complications: Implant prosthesis complications may occur due to

1. Functional cyclic loading

Synopsis (Cont'd)

2. Poor implant placement/site specific selection
3. Poor prosthetic design and selection of non-compatible (After market) materials
4. Inadequate treatment planning and lab communication
5. Inadequate understanding of implant prosthetic components and their indications
6. Errors inherent in the limitation of dental materials

Learning Objectives

A detailed understanding of the above concerns is critical.

1. A fractured abutment screw of a crown supported by an implant is an unhappy complication
2. For a screw to remain tight, the clamping force must be greater than the separating forces
3. Detailed discussion on factors that increase and or decrease screw loosening
4. Ideal torque techniques and implant specific torquing forces

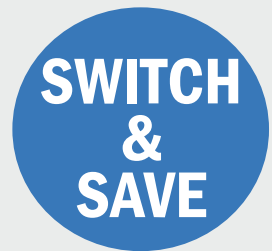
